

# Yes a Secondary Maricopa County Election 5 Findings

#### **Findings**

- 1. Markedly lopsided adjudication results
- 2. Completely tabulated ballots ≠ Cast Vote totals
- 3. As of 1-28-2023: Polling Marshals reported 8,000 unable to vote
- 4. Backdoor portal to voter records by NGOs -> MVD -> Counties
- 5. 298,000 Election Day Dropoff ballots lacked chain of custody

# Adjudicated Data Slog File Modified Ballot Shifts

- Candidate A: Non-adjudicated 49.5% Adjudicated 64%
- Candidate B: Non-adjudicated 51.1% Adjudicated 34.9%
- Adjudication Rate
   AZ county max = 4%
   Maricopa county = 14% (16.3M/94.4M)


Election Day: 9,204 ballots gone missing 10,001



#### Online Voter Registration Unique URL Program

The Arizona Secretary of State's Office has developed the Online Voter Registration (OVR) Unique URL Program to encourage organizations conducting large-scale voter registration drives to do so electronically and securely through the ServiceArizona website, rather than relying exclusively on paper forms.

Approved organizations participating in the Program will be assigned a unique URL to use and/or distribute for voter registration purposes and will receive periodic reports of valid voter registrations and updates submitted through their assigned URL.

The goals of the Program are to: (1) increase complete and valid voter registrations submitted through voter registration drives; (2) protect sensitive voter information collected during voter registration drives; and (3) reduce the burden on County Recorders and the Secretary of State's Office of processing paper registration forms from voter registration drives.

# **Special Action Signature Verification**

- Maricopa County failed to fully cooperate with details on signature verification.
- Special action was filed by legal team.
- Witnesses stated they were pressured to approve signatures. Maricopa County Asst Elections Director Celia Nabor supervised Signature Verification in last 3 elections.
- Deposition out for Celia Nabor.

## Signature Verification

Rey Valenzuela - " ... For a mail ballot, we don't request that you send your driver's license in, so that proof of identification is done through the signature verification on signature exemplars on file, vetted signature exemplars, registration form, multiple registration forms, that you may have on file. Also, past signature rosters. Maybe you're not an early voter, but you voted in person, we have all of those signature rosters and signatures, in addition to past EV affidavit, vetted EV affidavit signatures. As an example, I, myself, when we train, I have close to 32 different exemplars from all the times I voted and/or registration forms."

# Signature Verification and Chain of Custody

Signature Verification is the last line of defense and the County leans on that in the event Chain of Custody fails and ballots are injected into the system somewhere along the way.

# **Failed Chain of Custody**

- Maricopa county failed to track Chain of Custody of ballots from the polling centers to "central count" Maricopa County Tabulation & Election Center (MCTEC).
- No counts were complete prior to Maricopa county surrendering ballots to third-party vendor Runbeck.
- Runbeck scanned 35,000 more ballot envelopes into the total than they reported received from Maricona county.

# **Failed Chain of Custody**

MC Attorney LaRue: "like what happened at Runbeck, if somebody brings it and inserts it into the stream but not into a designated authorized drop box..."

Hobbs closing argument: "even if there were 50, 500, 500,000 ballots somehow injected into the process... every ballot received by Maricopa County is processed ...and then verified by a multilevel signature review process."

# **Failed Chain of Custody**

Maricopa County either withheld, deleted, or did not create chain of custody documents required by law.
